## The 'B team': Mevani reiterates demand for removal of Congress members who 'aligned' with BJP

REITERATING HIS demand to remove members from the party who are "the B team" or have allegedly aligned with the Bharatiya Janata Party (BJP), Gujarat Congress working president and Vadgam MLA Jignesh Mevani on Sunday hit out at the party leadership.

"Remove those who are not for the party. Why are you not removing them, why taking this disgrace? Remove them from the party so that this ends, the party gets clean and we together make the party strong, make Visavadar and Kadi seats strong."

## 'Cong fighting against corrupt bureaucrats'

Taking to X, Mevani also reacted to remarks made by Aam Aadmi Party (AAP) convenor Arvind Kejriwal who had alleged that the Congress serves the BJP, and not the public.

Mevani instead claimed that the Congress is fighting against the BJP, Sangh and corrupt bureaucrats.

"Arvind Kejriwal said that the Gujarat Congress is not serving the public, but the BJP. This is nonsense... You (Kejriwal) will return after four days, but the Gujarat Pradesh Congress Committee (GPCC) soldiers have been fighting since 25-30 years against the BJP and Sangh from taluka to district level. They are fighting against the corrupt bureaucrats. Our members at

taluka and district levels are strong and have been even sent behind bars," he said in a video message on the social media platform on Sunday.

Meanwhile, GPCC spokesperson Manish Doshi told this paper, "He should raise whatever issues he has with the party or its leaders on an appropriate platform, within the party. He is a leader and the working president too. He should avoid making such statements at this time (ahead of Visavadar and Kadi by-elections) and focus on strengthening the party."

Earlier on Saturday, Mevani had taken to X and expressed displeasure, stating: "Even leaders from the opposition parties are saying that your arsenal is full of inefficient members. Why hesitate? Unload them. What are you waiting for? The B team, those spent cartridges, the ones aligning with the enemy camp — what is the pain in getting rid of them? If not mine, at least heed Rahul (Gandhi)'s advice."

## Over 15,000 pet dogs registered in Ahmedabad since Jan 1; 64% of them between May 14 and 31

OVER 64 per cent of the total registrations of pet dogs recorded in Ahmedabad city since January 1 were done barely in last 18 days of May. Of the 15,476 registrations recorded till May 31, 9,928 were done in the last 18 days — between May 14 and 31 — shortly after a pet Rottweiler in the city mauled a four-month-old girl to death on May 12.

The attack reported in Radheya Residency, a residential society in Ahmedabad's Hathijan, had also left the child's aunt injured.

The pet later died of Babesiosis disease on May 27.

As per the Ahmedabad Municipal Corporation's (AMC's) Cattle Nuisance Control Department (CNCD) data, 8,780 owners registered 9,928 pet dogs in 18 days.

"This is against last three and a half months since the on-line pet dog registrations were launched by the Ahmedabad Municipal Corporation on January 1, 2025. Till May 13, a total of 4,874 owners registered 5,548 pet dogs," CNCD Head of Department Naresh Rajput told *The Indian Express*.

The trend also revealed that the highest daily registrations were reported on May 16 and 17 and then again while approaching the deadline, on May

29, 30 and 31.

## Deadline extended


On May 31, the AMC, which mandated online registration of pets under the 'Rabies-free Ahmedabad city-2030' campaign, extended the deadline by another month.

Previously, this deadline was extended twice.

However, this time, the registration fee of Rs 200 per dog has been increased to Rs 500 from June 1 till 30 and owners have to compulsorily register their pet dogs by applying online on the official website.

There is not a single Rottweiler among the 5,520 pet dogs registered by 4,848 owners. As per AMC data, among the registered breeds are German Shepherd (Alsation), Labrador, Golden Retriever, Shih Tzu, Pomeranian, Pug, Doberman, Siberian Husky.

The highest registration was reported from the west zone where over 3,300 dogs were registered by nearly 2,900 owners, followed by north west zone where over 2,700 pet dogs were registered by nearly 2,400 owners.
