Ex-minister refused to speak to hostage taker, says senior cop

AMID THE nearly three-hour long hostage drama in Powai on October 30, accused Rohit Arya had asked police personnel to connect him with former school education minister Deepak Kesarkar, whom he blamed for alleged non-payment of dues of work he did for the department, an IPS officer told *The Indian Express*. When the personnel approached Kesarkar, he refused to speak to Arya and told them to connect the accused with officials in the school education department, the officer said.

When contacted, Kesarkar told *The Indian Express* that he declined to speak to Arya as he felt the hostage-taker should speak to the officials "responsible" for the dues. The former minister, however, added, "I did not realise the matter would become so serious."

During negotiations, Arya told police that he was upset over non-payments of dues for a project he did for the school education department. "The person whom he wanted to ask questions was Kesarkar and accordingly, a DCP-rank officer called him up and apprised him of the situation. The former minister, however, refused to speak to Arya," the officer said.

Kesarkar said, "Initially it was not possible to talk to him as police were not in a position to connect. When I realised that the issue was regarding the pendency of dues, I told them to connect him with the department officials...I did not realise the matter would become so serious as

there was no way to know such a thing."

In the video released by Rohit Arya during the hostage crisis, he said, "I have very simple demands. Very moral and ethical demands. I have some questions. I want to speak to some people and on their answers, if there are any counter questions, I want to ask them. But I want these answers...I am not a terrorist, nor do I have any demand for money..."

Eventually an officer entered the studio and shot him dead. Nineteen people, including 17 children, who had been held hostage were freed.

The official said during those two hours, the police team, including Powai senior inspector Jitendra Sonawane and zonal DCP Datta Nalawade, negotiated with Arya through video calls. Police also got the parents of the children to plead to him but he did not relent and insisted on "getting answers to his questions". As police saw Arya getting restless and aggressive, they decided to go ahead with plan B, which included entering the room from the bathroom window through a back entrance.

The Maharashtra State Human Rights Commission has taken cognisance of the hostage incident and sought details from Mumbai Police. The commission also asked the investigation wing of the commission headed by Vishwas Pandhare along with VP Kedar, registrar of the panel, to probe the death and submit a report with all evidence collected during the inquiry. The matter was posted for hearing before the SHRC on January 8.

Chouhan asks officials to probe ‘paltry payments’ under PM Fasal Bima Yojana

UNION AGRICULTURE Minister Shivraj Singh Chouhan has ordered "thorough on-field investigations" into paltry payments, as low as Re 1, to farmers under the Pradhan Mantri Fasal Bima Yojana, saying it's a "mockery".

Chairing a high-level meeting in Delhi on Monday to discuss issues being faced by farmers regarding the insurance scheme, Chouhan said farmers shouldn't feel troubled under any circumstances, a statement from the ministry said.

"Receiving claims of Re 1, Rs 3, Rs 5, or Rs 21 is a mockery... and the government will not allow this to continue," the statement quoted Chouhan as saying.

He instructed officials to make necessary amendments to the scheme provisions to re-

During the meeting, Chouhan pointed out that a farmer was paid Re 1 when the loss was shown as zero; another farmer's loss was recorded as 0.004806% and the claim was Re 1. Chouhan asked if this was not "injustice" with farmers.

Celina Jaitly's brother detained in UAE, Delhi HC asks Centre to provide legal aid

THE DELHI High Court on Monday directed the Centre to take steps to provide effective legal representation to actress Celina Jaitly's brother, Major (retd) Vikrant Kumar Jaitly, who has been in detention in the UAE over an alleged "national security case" since September last year.

Seeking a response from the Centre on Celina's petition, Justice Sachin Datta also directed that an attempt should be made to ensure contact between the actress and her brother, with Celina highlighting that she is his "sole surviving immediate blood relative".

The court has also directed for appointment of a nodal officer to liaise with the UAE authorities.

Celina, represented by advocates Raghav Kacker, Ribhav Pande and Madhav Aggarwal, had moved the Delhi HC claiming that her brother was illegally abducted and detained in UAE on September 6, 2024. She claimed that for the past year, she has failed to secure basic information about her brother despite repeated requests and representations to the Indian authorities.

On Monday, the Centre's counsel told the HC that Vikrant has been arrested "for a national security-related case in UAE" and that the Indian authorities have been in correspondence with his wife and has provided him with consular access.

Six killed in car-truck crash in UP's Barabanki

Barabanki: Six people were killed and two others seriously injured when a car and a truck collided head-on in Barabanki district of Uttar Pradesh on Monday evening, officials said.
